Having been in the position for 8 years, I know that I can perform the duties and help direct the Club in a Secure, Safe, and Open for All manner. I look forward to how 2021 can be a year of healing and rediscover of all the activities and benefits that our Club brings to our members and the boating community. Lee Panza (Incumbent)

For the first time in memory, an office of the SPYC is contested, so you have an important decision to make. The SPYC Treasurer is the CFO of this corporation. The position is technical, and data-driven, and arguably the most demanding position our organization. Therefore, I'd like to help you make an informed choice.

In 2019 the Club's Treasurer decided to step down, and I stepped up to replace her. With my relevant experience it was a natural transition that prevented a disruption in the management of our Club's finances. I had been a Charter Member of the SPYC, but I chose to focus my time on the Brisbane Lions Club instead. Having recently retired, I rejoined the SPYC and have become extensively involved. I had been fully enjoying the Club's social activities until they had to be curtailed due to the COVID pandemic. This summer I served as photographer for the beer can races, taking action photos of our participants. Earlier this year I helped organize an extensive list of possible Club enhancements suggested by various members. And, I have the time and energy to do the job of Treasurer the way it should be done!

When I started my own construction company I studied the fundamentals of accounting and set up a full dual-entry, accrual financial records system that kept revenues from different jobs from becoming comingled and allowed me to succeed on a tight margin. I've also served as the Treasurer of the Brisbane Lions Club for 13 years;

what began as a small operation of a few thousand dollars annually grew into a system of five segregated funds managing over a half-million dollars in assets. Late in my career, studying on my own, I passed the two-day exam earning my license as a Professional Engineer, and I worked as a consulting Civil Engineer for a number of government agencies before I settled on the City of Pacifica. A Civil Engineer needs to be detail-oriented and almost obsessed with accuracy; mistakes can be costly and get people hurt.

I believe this background bears on my capability as a proficient and effective Treasurer for the SPYC.

In less than a year I've already made significant improvements, starting with a comprehensive overhaul of our financial records system to provide clear, informative financial statements allowing the Board of Directors to more effectively manage our club's money. Then, the Board agreed to allow me to post the general financial statements on our website, making it easier for you to see how your money is being managed (please contact me directly if you ever have any questions).

One of the most important of the suggested Club improvements on the list that I mentioned earlier was to upgrade our point-of-sales revenue management system. We have been operating with a primitive cash register, a disorganized system of hand-written bar tabs (which don't always get paid-off), and open containers of cash on the bar. Better revenue control is something I will be emphasizing.

After I did an enormous amount of research your Board of Directors has agreed to acquire a computerized system that will protect our cash, facilitate members making casual purchases and volunteer bartenders working at busy Club

events, allow for paid-in-advance bar tabs via pre-authorized credit card commitments, maintain inventory control, and provide data for making intelligent future pricing decisions. The ongoing cost will be well under a dollar a day above what we had been paying, and it will be the Club's most valuable investment in financial management in many years. By the time you read this I should be busy integrating it into our operations and resolving the inevitable start-up issues. I've also been compiling a detailed procedures manual, covering everything the Treasurer does, which I'll now be revising for our new point-of-sale system. To appoint future club treasurers, anyone who is not intimidated by numbers, and who is thorough and attentive to detail, will be able to simply follow the written instructions. A well-managed organization needs to provide effective succession for a position that could otherwise overwhelm a volunteer.

Since the COVID pandemic took hold around us I've been strenuously advocating that we suspend our bar operations to do our best to help stop this disease. Indeed, bars throughout California are still closed, because it's been clear that bars have been one of the worst vectors for spreading COVID-19, and the virus won't distinguish between private bars and public bars. I want to resume socializing at our Club as much as anyone, but I've been urging that we exercise greater restraint until this pandemic is under control. While this has been unpopular with some, the election for this office is not a popularity contest; what's most important in a Treasurer is competence, and I hope you'll agree that I've been demonstrating that.

This is an important decision for you to make. I hope you'll allow me to continue the work I've been doing, and I thank you for your confidence in me. I am so looking forward to you and I being able to safely resume the wonderfully enjoyable social activities that we all joined this club for.

The Club Reopening Committee updates the SPYC rules given the current San Mateo County status and contacts with ABC and local enforcement agencies.

We are happy that SPYC can continue to stay open and want to make sure our members are as safe as possible at the club. At this time giving the limitations of deck space allow members only to use the club.

The rules allow for outdoor dining on the deck and bar service only with food. The club has purchased a number of single service food items for purchase to eat at the club. We have a variety of sandwiches and salads. We are open to other suggestions from members.

We want all our members to work with us on continued education of safe practices at the club. Masks must be worn when members are not seated and not eating or drinking. The mask rule is to be followed inside and on the deck. As with everywhere we go these days please try to maintain social distancing of six feet when moving about the club. The Officer of the Day's name is on the white board in the lobby and that is the go to person if you have concerns about practices by members at the club related to safe practices. There is a list of OOD duties on the Board.

9. Member Articles - The Jolly Roger

The so called Golden Age of Piracy (1650-1725) was mainly concentrated on the Caribbean trade routes, where sailing ships carried rich cargoes from the New World to the Old. In 1716 with the end of the Spanish War, hundreds of seamen were laid off from their work as privateers, these seamen

were happy to sign on for the next adventure.

Rather than receiving the scorn deserved, these pirates caught the imagination of the public as folklore hero's. Tales of the derring -do of violent characters such as Henry Morgan; Capitan Kidd; 'Calico' Jack Rackham; Edward 'Blackbeard' Teach and Bartholomew 'Black Bart' Roberts became legendary. The Jolly Roger became their flag, with backgrounds of black for 'death' or red for 'blood. Pirates sailing into an anchorage of 'prizes' would fly no flags or false flags to fool their victims. Once in position, the Jolly Roger was raised to alarming the target crew into submission. A black Jolly Roger meant surrender now and your life will be saved. If that was ignored a red flag was raised meaning no mercy would be shown if the victim did not surrender.
